Revolving restaurant with fantastic views

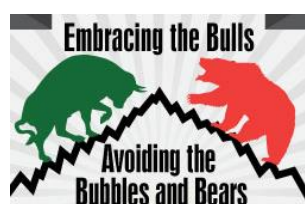

the conference focus of bulls, bubbles and bears, Tim Walker will deliver the first session on Friday morning with an overview of the market bubbles and busts over the decades. This will help to set the scene for the rest of the conference — full of tips to help you look out for any future pending market bubbles, and be better prepared to either avoid the carnage, or take advantage of the opportunities. And every bubble, bust and bear is eventually followed by a bull market — so how can we take advantage of this?

Conference accommodation — Stay at the conference venue, the Crowne Plaza where special accommodation rates have been negotiated for delegates. Alternatively, there are many other accommodation options nearby ranging from single-bed flats, to multi-bedroom apartments.

Trading ideas — The conference program will include discussion of a number of realistic trading ideas and strategies, so be ready to take a lot of notes. Travel and transport — Transport to the hotel is easy, with domestic and international flights into the nearby Gold Coast airport (Coolangatta), or the more distant Brisbane international airport. It's easy to get around the Gold Coast using the G:link light rail service that stops at the front door of the hotel (at the Florida Gardens station). The G: light rail system services a 13 kilometre stretch from Gold Coast University Hospital in the north to Broadbeach in the south. Be on the lookout for special discount airfares which are offered from time to time by the major airlines.

Registration — The conference fee includes lunches on all three days and the Saturday night Conference Dinner for all delegates. The all-inclusive ATAA member registration fee is only \$750 (inc GST).
